

**Union Township  
December 2, 2024  
Regular Trustee Meeting**

The Union Township Trustees met on December 2, 2024, at 7:00 pm for a regular meeting. The Fiscal Officer Karen Nethers Roll Call showed the following trustees: Roger Start, Jeff Sharps and John Slater. Administrator Paula Greene and Dave Cable, Road Superintendent, were present. Trustee Start led the Pledge of Allegiance. Guests – Bill McWilliams and Tim Allen.

Minutes – Mr. Slater motioned, and Mr. Sharps seconded to approve the November 18 minutes. Motion carried.

Bills – Mr. Slater motioned, and Mr. Sharps, seconded to approve the bills. Motion carried.

**Public Comments** – Tim Allen, Lancaster Road, discussed concerns of a cell tower that is to be installed near his residence. Mr. Allen said he understood the Township has little or no authority. Mr. Allen asked when the zoning resolution update will be ready.

Gas aggregation program – Mr. Start reported the township can join the County’s gas aggregation program which will reduce the ccf cost. The program ends December 30, 2025.

**Motion – Mr. Slater moved, and Mr. Sharps seconded to authorize Mr. Start to enroll the township in the Licking County Aggregation program IGS program for the township building at 526 E. Main Street. Motion carried.**

Licking County Transit – Paula attended a meeting to discuss Transit needs in the Township.


**Economic Development & Public Comments** - None


**Trustees**
