

**Union Township Trustees
Regular Meeting Minutes
March 20, 2023**

The Union Township Trustees met in regular session on March 20, 2023, at 7:00 pm. Fiscal Officer Jessica Slater's roll call showed the following trustees: John Slater and Roger Start present. Trustee Jeff Sharps was absent. Paula Greene, Township Administrator and Dave Cable, Road Supervisor were present. Trustee Slater led the Pledge of Allegiance. Guests: Patrice Francis and Martha Cable.

Minutes – Mr. Start motioned and Mr. Slater seconded the approval of the February 20 regular and the February 9 Economic Development special meeting minutes. Motion carried.

Bills-Mr. Start motioned and Mr. Slater seconded to approve the bills. Motion carried.

Public Comments

Patrice Francis said she felt the Township's website needed additional information regarding Fire and EMS service in Union Township. Ms. Francis said the Granville Township and West Licking Fire District's website is more descriptive. 




