February 3, 2025
Regular Trustee Meeting**

The Union Township Trustees met on February 18, 2025, at 7:05 pm. The Fiscal Officer, Karen Nethers, conducted a roll call showing trustees Roger Start, Jeff Sharps, and John Slater (arrived at 7:11 pm). Administrator Paula Greene was present. Trustee Start led the Pledge of Allegiance.

Minutes –Mr. Sharps motioned, and Mr. Start seconded to approve the February 3 meeting minutes. Motion carried.

Bills – Mr. Sharps motioned, and Mr. Slater, seconded to approve the bills. Motion carried.

Public Comments – none

Fiscal Officer – Mrs. Nethers stated that she received the new laptop and printer from the state and has them set up. She is working on the permanent budget due in April

Administration

Map Amendment – The Zoning Commission approved a CMZ map amendment. The Trustees scheduled their hearing date for March 3 at 6:30pm.

Mowing Bid – The mowing contract is due to go out for bid. Ms. Greene requested the bid opening be set for March 17 at 7:15pm.

- Motion – Mr. Start moved, and Mr. Sharps seconded, to proceed with the mowing bid contract with the bid opening to be held on March 17 at 7:15pm. The motion carried.

Trash Contract – The contract is up for renewal. Per the contract, Shackleford may extend the contract for three years. The company can submit a price increase. The Trustees will have the opportunity to either accept the new prices or place the contract out for bid.

- Motion – Mr. Sharps motioned, and Mr. Slater seconded, to offer the extension to Shackleford Disposal with cost revisions for the Trustees to review. The motion carried.

District Advisory Council – The yearly DAC meeting will be held on March 14. The Trustees appointed Ms. Greene to attend.

- Motion – Mr. Slater motioned, and Mr. Start seconded, to appoint Ms. Greene as the Township's representative to the DAC meeting. The motion carried.


Economic Development

Trustees – No comments.


With no further business Mr. Sharps motioned to adjourn, and Mr. Slater seconded.
Meeting adjourned at 7:25pm.





