**Regular Trustee Meeting**

The Union Township Trustees held a regular meeting on July 21, 2025, at 7:00 pm. The Fiscal Officer, Karen Nethers, called Roll, with the following trustees present: Roger Start and John Slater. Mr. Sharps was absent. Administrator Paula Greene and Road Superintendent Dave Cable were also in attendance. Trustee Start led the Pledge of Allegiance. Guest: Bill McWilliams and Martha Cable

Minutes – Mr. Slater motioned, and Mr. Sharps seconded to approve the July 7 Regular meeting. Motion Carried.

Bills – Mr. Slater motioned, and Mr. Start, seconded to approve the bills. Motion carried.

**Fiscal Officer**

Audit update- The State Auditor expected to conclude in office visits soon.

Vacant Position – Posted opening on Indeed job website. Received several applications.

**Road and Bridge**

Tractor – Mowing operations have stopped due to mechanical problems with the boom. Options for repair and the expected timeline were discussed. The tire rim has been repaired.

Refugee Cemetery – Contacting tree service providers has been challenging. Estimates are expected soon.

EPA Audit – The township passed its part of the recent countywide EPA audit with good status.

Speed Limit – Mr. Start inquired about lowering speed limits; this will be reviewed.

**Administration**

Zoning Resolution Update – Attorney Carnes has submitted her comments. A date for the Planning review has not yet been scheduled.

Violation – Efforts are ongoing to address the Food Truck Violation. The food truck is scheduled for removal by August 1.

Robertson Drive – Paula met with Chad Brown, Health Director, as well as Assistant Prosecutors Carolyn Carnes and Darcy Cook, to discuss the issues related to the property. It was determined that a permanent solution is needed, given the property's location in a flood plain, which makes it unsuitable for residential development. Additional matters, such as identifying properties currently in foreclosure, will require further investigation.

There being no further business Mr. Start moved to adjourn the meeting. Mr. Slater seconded. Meeting adjourned at 7:19pm.


