<u>Road and Bridge</u> – Snow event went well, and we are good on salt. The garage door opener needs replaced due to age and wear. A new system including tracks and opener are estimated to cost \$1044.00 from Newark Overhead Door.

Mini-hoe tracks – Need to replace tracks. Mr. Slater and Dave have researched options. Southeastern Equipment estimate to replace is \$2992.28 with street department installing the new tracks.

Motion – Mr. Slater motioned to approve; Mr. Start seconded the purchase of mini-hoe tracks from Southeastern Equipment in the amount of \$2882.28. Motion carried.

<u>Administration</u>- Zoning Commission will hold a workshop on January 22 to review Zoning Resolution Draft. The Zoning Commission will also hear a map amendment request on February 5 at 6:30pm.
